General rules

Article 1

The term „Renting Space “consider all rooms in the right part of building, dedicated to cultural, social and sport activities.

Article 2

During Islamic Holidays the rooms from Article 1 can't be used in non-Islamic purposes.

Article 3

All activities in the rooms from Article 1 to be stop for daily prayer time.

Article 4

In the Month of Ramadan, the rooms from Article 1 cannot be rented.

Article 5

The program of Event needs to presented to Coordination Members in the time of signing rental agreement.

Article 6

During the event will not be tolerated any activities, not complied with Islamic Religion, as

- Selling or using alcohol,
- Music with unappropriated text, as well as speech who could hurt national pride and Islamic believing of Bosnian community members.

Article 7

During the Event, at least one member of Board of Directors must be present and take care of building and renter needs.

Article 8

The rooms from Article 1 to be protected by permanent or periodically present of police officer.

The rental rooms need to be returned to owner in original condition before noon of following day.

Article 9

Coordination Committee consist 3 members:

1. The President of Committee for social activities,
2. The Vice President of Board of Directors,
3. The Board Member.

Article 10

In the case that the Coordination Committee can't bring decision unanimously, final decision will be done by Board of Directors after very precise explanation of every member of Coordination Committee. All procedure must be completed in the time period no later than 7 days.

Article 11

The rooms from Article 1 can be rented by members of Bosnian Community as well as other private and business subjects.

Article 12

In the case of multiple requests for renting, Community members have priority.

Article 13

In the case of multiple requests for renting by Community members, decision will be made on first come first serve basis.

Article 14

In the case of the same day multiple requests, decision will be made in favor of greater donator

Finance rules

Article 15

- Renting price for full room (40 tables and 320 chairs) is \$ 2000.00 (two thousand dollars),
- Renting price for room with 30 tables and 240 chairs is \$1800.00 (eighteen hundred dollars),
- Renting price for room with 20 tables and 160 chairs is \$1600.00 (sixteen hundred dollars),
- Renting price for room with 15 tables and 120 chairs is \$1400.00 (fourteen hundred dollars),
- Renting price for room with 10 tables and 80 chairs is \$1000.00 (one thousand dollars),
- Penalty for Hours after midnight for room – 1 is \$50 / Hour (fifty dollars per hour)
- Renting price for room per hour \$200

Article 16

Community members are eligible for discount based on donation amount.

Total discount cannot exceed 50%.

Article 17

The renter needs to pay deposit in amount of \$500 (five hundred dollars). The deposit will be returned to renter if rooms are returned to Owner without any damage.

Article 18

The mixer and sound system rental price are \$200 (two hundred dollars)

Article 19

The room and kitchen can be rented to Community members for \$300 (three hundred dollars).

The room 2 and kitchen can be rented to non-Community members for \$500 (five hundred dollars).

The renter needs to pay deposit in amount of \$500 (five hundred dollars). The deposit will be returned to Renter if rooms are returned to Owner without any damage, cleaned.

Article 20

Every event in Community property must be approved by Coordination Committee.

Article 21

The mass events must be protected by police officer.

Article 22

The event needs to be paused during the prayer time, to allow normal pray condition.

This Bylaw has been accepted by Board of Directors on January 6, 2013.
