Rules and Regulation "Humanitarni Fond Atlanta"

I. GENERAL PROVISIONS

Article 1

The founder of the humanitarian fund is the Community of Bosniaks of Georgia Inc.

Article 2

The fund operates under the name: " Humanitarni Fond Atlanta ", and it is part of the Community of Bosniak Georgia, Inc.

Consistent with Article VII of the Articles of Incorporation of Community of Bosniaks Georgia, Inc., the Humanitarni Fond Atlanta shall be operated solely for charitable, educational, religious, and other purposes permitted under the Section 501(C)(3) of the Internal Revenue Code.

Humanitarni Fond Atlanta has its own Logo and Facebook page (Humanitarni Fond Atlanta)

Article 3

The Humanitarni Fond Atlanta headquarter is at 950 Grayson Highway, Lawrenceville, GA 30046

Article 4

The Humanitarni Fond Atlanta is managed by the board consisting of at least 6 members:

- Fund manager
- Two members from the Board of Directors of Community of Bosniak Georgia, Inc.
- Two active members from the Community of Bosniak Georgia, Inc. membership.
- One representative from a state inside the USA that has at least 20 members of Humanitarni Fond Atlanta.

The members of the Board of The Humanitarni Fond Atlanta shall be appointed by the Board of Directors of Community of Bosniak Georgia, Inc., they will serve at the discretion of the Board of Directors of Community of Bosniak Georgia, Inc. and any member may be removed at any time, with or without cause by the Board of Directors of Community of Bosniak Georgia, Inc. Nominations for persons to serve on The Humanitarni Fond Atlanta may be submitted for consideration to the Board of Directors of Community of Bosniak Georgia by any member of The Humanitarni Fond Atlanta.

Article 5

The Humanitarni Fond Atlanta is a humanitarian organization of members of the Community of Bosniaks of Georgia, based on principles of voluntariness and solidarity is established by a decision of the Community of Bosniaks Georgia, Inc. Board of Directors.

The members of the Humanitarni Fond Atlanta can be anyone who wants to, regardless of which the Federal State of America they live in.

Article 6

The Fund Manager and the Fund Board are responsible for the proper application of the provisions of this ordinance.

Article 7

Following the needs, and to increase membership, the Fund Manager and the Fund Board have the right to appoint associates and representatives of the Humanitarni Fond Atlanta, in the territory of any Federal State of the United States.

III. FUND OBJECTIVES

Article 8

The goals of the Humanitarni Fond Atlanta are providing financial assistance in Bosnia and Herzegovina for:

- persons whose basic existential needs are endangered,
 - sick persons,
 - families in Bosnia and Herzegovina.
- Scholarships for excellent students and students of poor financial status. The amount of scholarship is decided by the Fund Board.

IV. ASSISTANCE CRITERIA

Article 9

Grants shall be awarded by the Fund Board based on the criteria presented to and approved by the Board of Directors of Community of Bosniak Georgia, Inc. The Fund Board shall prepare and present to the Board of Directors of Community of Bosniak Georgia, Inc. for approval on an annual basis the criteria upon which grants shall be awarded by the Fund. Once approved by the Board of Directors of Community of Bosniak Georgia, Inc., the Fund Board shall not make changes to the award criteria without first obtaining the approval of the Board of Directors of Community of Bosniak Georgia, Inc. Under no circumstances will any grant be awarded the Fund Board that is not consistent with Article VII of the Articles of Incorporation of Community of Bosniaks Georgia, Inc. The Fund Board shall prepare and present to the Board of Directors of

Community of Bosniak Georgia, Inc., on such schedule as the Board of Directors of Community of Bosniak Georgia, Inc. shall determine, a report of the financial condition and operation of the Fund, to include a statement of Fund income and expenses, the amount of grants awarded and the purposes for which such grants were awarded.

Article 10

Donations are realized through:

- TV show "Ispuni mi želju ", produced by Hayat TV
- TV show "Istina TV" hosted by Munira Dzabija
- And in other ways, if the Fund Board decides so

V. MEMBERSHIP AND FUNDS OF THE FUND

Article 11

1. Membership in the Humanitarni Fond Atlanta is voluntary
2. A member of the Humanitarni Fond Atlanta may be any person who wishes
3. He becomes a member of the Humanitarni Fond Atlanta by paying the first membership fee
4. A member of the Humanitarni Fond Atlanta, in addition to the membership fee, may pay certain funds in the form of a donation
5. Membership in the Humanitarni Fond Atlanta is confirmed by the documentation on the payment of membership fees
6. No special membership card is issued for membership in the Fund

Article 12

Membership in the Humanitarni Fond Atlanta terminates:

1. By expressing a desire to leave the Fund
2. Failure to pay the membership fee for a period longer than one year

Article 13

The monthly membership fee is \$ 10.

The membership fee can be paid in advance for several months, and at the choice of the member. A member of the Humanitarni Fond Atlanta may, due to exceptional circumstances, temporarily suspend the payment of membership fees, and continue to pay when he chose so.

VI. MEMBERSHIP INFORMATION

Article 14

Receipts for membership fees are delivered in person or sent by mail.

Article 15

Confirmations on the donation paid for Hayat TV shows "Ispuni mi želju" and Istina TV, videos on the delivered donation, as well as all other information are submitted to the membership via e-mail, Facebook page, and WEB page.

VII TRANSITIONAL AND FINAL PROVISIONS

Article 16

In case of the dissolution of the Humanitarni Fond Atlanta, the remaining funds can be remitted to a related humanitarian organization, return to members or leave to the founder.

Article 17

The Rule book enters into effect after its adoption by the Board of Directors of Community of Bosniaks Georgia Inc.
